You are receiving this letter as a notification that a Philadelphia Water Department (PWD) construction job is beginning in your neighborhood. PWD has identified the water mains below as those that need to be replaced, to increase service reliability and reduce the chance of breakages.

Our work will take place in the coming months on the blocks listed below, in your neighborhood. We want you to be aware of possible disruptions and traffic delays. This project will take place at these locations:
