Dear Philadelphia Water Customer:

You are receiving this letter as a notification that a Water Department construction job is soon to begin in your neighborhood. The blocks listed below are the blocks on which work will soon take place. As a neighbor in the same community, we want you to be aware of possible traffic disruptions and delays while this work is ongoing.

PWD Operations made emergency repairs to the sewer along the 1600 block of S 12th St to stabilize the issues in Spring 2025. This was in response to the sewage issues and sinkholes along the block.

Emergency Project #41261 (1600 Block of S 12th: E. Passyunk Ave - Tasker Ave.) will include:

- New Sewer with larger pipe capacity to increase service reliability by reducing clogs & backups
- New Water Main to increase service reliability & reduce emergency breaks
- Possible Lead Service Line (LSL) Replacement in compliance with new federal environmental regulations
- Street Repaying of the block, with street, sidewalks, and rights-of-way restored

- During normal working hours (7:00am-3:30pm), it may be necessary to close the street
- Trash and recycling should be placed at the curb as regularly scheduled
- This project has both an engineer and inspector who will be on-site regularly to ensure that the work proceeds in a safe and professional manner
- Talk with the inspector on the job site who will be wearing clothing identifying them as a PWD employee; their contact information is also on the Project Page site listed above
- If a water service line needs to be shut-off, the inspector will notify your block one day in advance

If you are unable to contact the inspector at the job site, or have any other questions, please contact the engineer at the number listed below between 8:00 a.m. - 4:30 p.m. Monday thru Friday.
