Dear PWD Customer, Property Owner, and/or Current Occupant,

The Philadelphia Water Department (PWD) is planning an exciting **construction project near your property** that will manage stormwater runoff while creating safer and more beautiful streets.

This project is part of the City of Philadelphia's *Green City, Clean Waters* plan, a 25-year initiative to improve the quality of our waterways by installing green stormwater infrastructure (GSI) in our neighborhoods, coupled with traditional infrastructure like collection, pumping, and wastewater treatment plant enhancements. As part of this construction project, PWD is planning to complete the following work through **PWD GSI Project #50176 Girard Estates Green Streets**, as seen below:

- Stormwater Infrastructure Upgrades
 - A series of **stormwater tree trenches** along Porter Street between 19th & 21st Streets
 - A series of **stormwater bumpouts and tree trenches** along Ritner Street between 20th & 21st Streets and a singular **stormwater tree trench** at Ritner & 18th Street
 - A series of **stormwater bumpouts and tree trenches** along Wolf Street between Woodstock Street & 19th Street
 - A series of **stormwater tree trenches** on both 19th and 20th Streets between Ritner & Wolf Streets
- Drinking Water Infrastructure Upgrades
 - Water main replacement on Wolf Street from 19th to Woodstock Streets

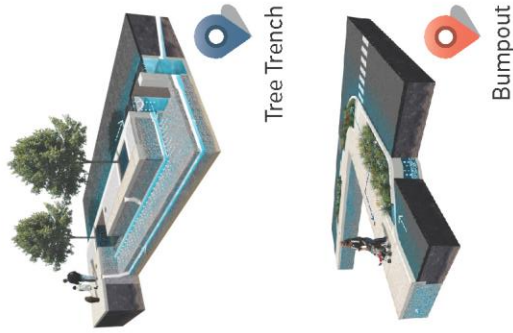
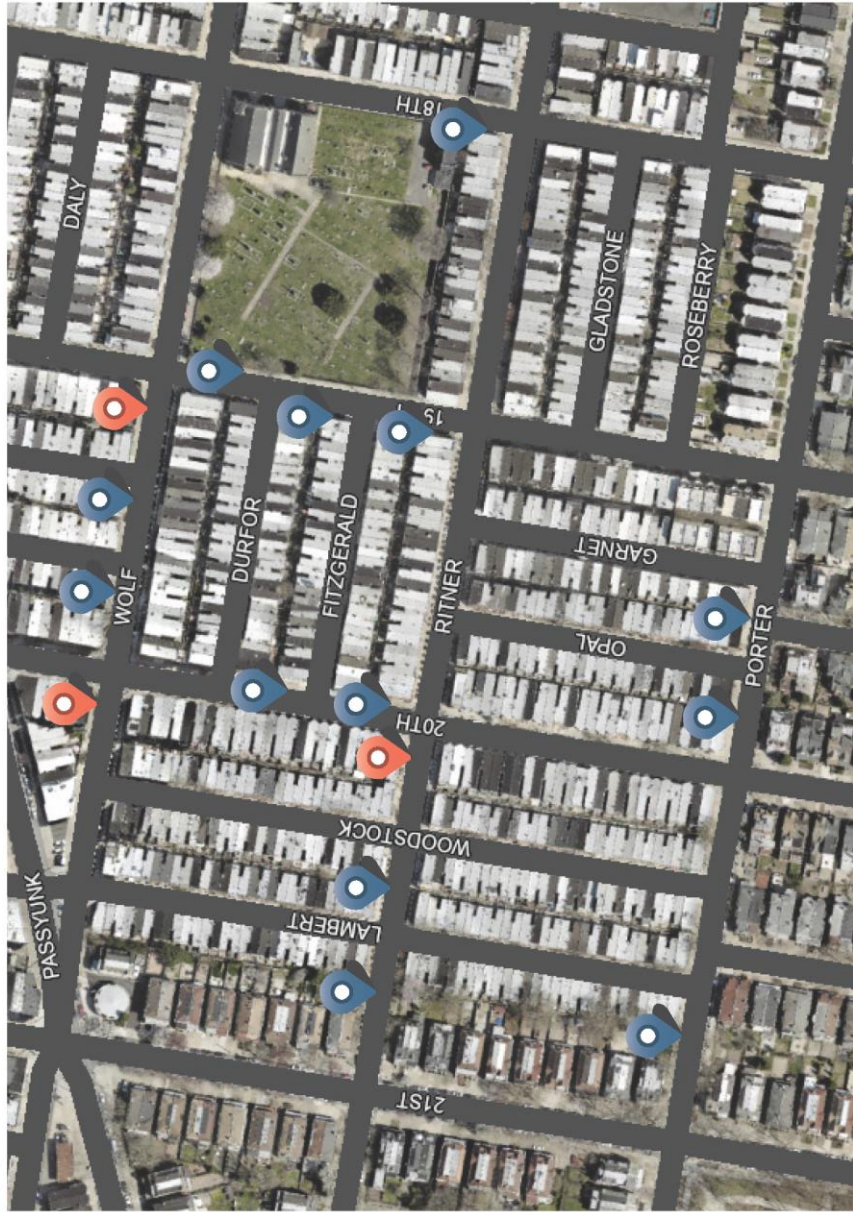
