Dear PWD Customer, Property Owner, or Current Occupant,

You are receiving this letter because a Philadelphia Water Department (PWD) construction job is beginning in your neighborhood. Residents should be aware of disruptions and delays while this work is ongoing.

This project will build green stormwater infrastructure (GSI) systems to increase the service reliability and climate resilience of your neighborhood. GSI systems capture stormwater to protect local waterways by preventing combined sewer overflows.

GSI systems will be built in the public right of way (streets & sidewalks) and/or on public parcels. Public GSI projects like this one are built through our 25-year stormwater management plan called *Green City, Clean Waters*. Learn more here: water.phila.gov/green-city.

What Residents Need to Know During Construction

- All work for this project is being done in the public right-of-way. Once construction begins, PWD does not make changes to projects.
- During normal working hours (7:00am-3:30pm), it may be necessary to close the street.
- Trash and recycling should be placed at the curb as regularly scheduled.
- An inspector will be on-site regularly to ensure that the work proceeds in a safe and professional manner; this is who residents should speak to with questions.

- If a water service line needs to be shut off, the inspector will notify your block one day in advance.

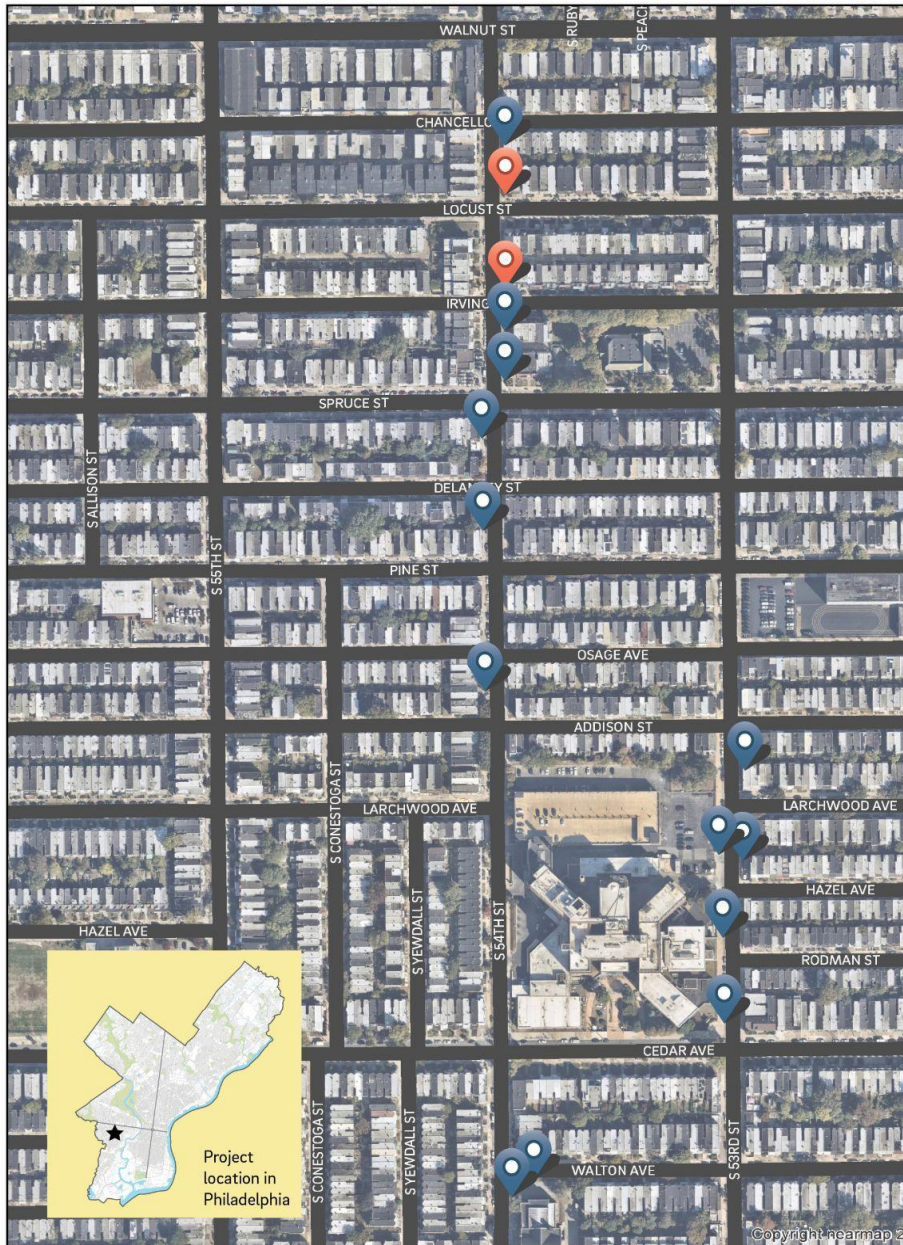
