Re: Extension Request of Consent Order and Agreement

Dear Mr. Magge:

The City of Philadelphia Water Department (City) would like to request an extension to the milestone dates of the Year 10 performance standards and deliverables under the Consent Order and Agreement, entered into by the Commonwealth of Pennsylvania, Department of Environmental Protection and the City on June 1, 2011 (COA), due to impacts from the COVID-19 pandemic. The City is seeking a sevenmonth extension until December 31, 2021 to achieve the Year 10 Water Quality Based Effluent Limits performance standards of the COA. Further, in accordance with the schedule and timeline provided in the COA (under Paragraph 3.e and Appendix I), the City is requesting for the submission deadline of the Year 10 Evaluation and Adaptation Plan to be extended seven months to May 30, 2022. The preparation and completion of the Evaluation and Adaptation Plan requires sequential processing, modeling, and evaluations. The submission of the FY21 NPDES CSO Permit Annual Report would remain September 30, 2021.

This letter is in response to the City of Philadelphia Water Department's (City) April 6, 2021 letter regarding an extension to the milestone dates of the Year 10 performance standards and deliverables under the June 1, 2011 Consent Order and Agreement (COA) between the Department of Environmental Protection (DEP) and the City, due to impacts from the COVID-19 pandemic.

DEP has completed its review of the provided information and has determined that the City has exercised all reasonable diligence and is unable to prevent the circumstances leading to the anticipated delay. The request for an extension under Section 15. (Force Majeure) of the COA is hereby approved in full, subject to the included schedule:

An extension until December 31, 2021 to achieve the Year 10 Water Quality Based Effluent Limits performance standards of the COA is hereby approved. The schedule and timeline under Paragraph 3.e and Appendix I of the COA for the submission of the Year 10 Evaluation and Adaptation Plan is extended to May 30, 2022.

The submission of the FY21 NPDES CSO Permit Annual Report will remain September 30, 2021.
