

GSSD Unit Design Review Contacts

All Green Stormwater Infrastructure (GSI) or Environmental Restoration (ER) designs, once approved by PWD, must be submitted to the following agencies and groups for review. The PWD project manager must be copied on all submissions by Provider. Reviews that apply to GSI projects are highlighted in green, ER projects in blue, and reviews that could apply to GSI or ER projects are highlighted in orange. Depending on the project, review and/or permits may be required by other agencies that are not listed. Projects with water/sewer must also be reviewed by the units/agencies listed in Section 6 of the PWD Water & Sewer Design Manual. Unique partner and pilot projects may have additional review requirements. PWD project manager can provide guidance. All conflicts arising from reviews should be resolved prior to Plans, Specifications, and Estimate (PWD 90%) submission.

Note on Access Permits: For projects on Philadelphia Parks & Recreation, School District of Philadelphia, vacant lots, PRA, or SEPTA property, right-of-entry authorization and permits are required for on-site access.
